RELEASE AND WAIVER OF CLAIMS

The undersigned, who is a spectator or participating dog training activities, including, but not limited to agility, obedience or trick training, in consideration of use of facilities covenants and agrees as follows:

General Release. The undersigned hereby releases and waives any claims that the undersigned may now or hereafter have against the dog training facility, dog training activity sponsor(s), Jeanne Shaw, her instructors, coaches or their assigns from and against any and all liabilities, losses, damages, costs or expenses of whatever kind or nature, including attorney's fees, which the undersigned may incur as a result of any injury to the undersigned or their dog(s), or personal property of the undersigned as a result of the undersigned's activities undertaken at said facility including, without limitation, personal injury and damages thereof including loss of income, earnings, bodily injury, pain and suffering, emotional or mental distress and any and all medical expenses.

Assumption of Risk. The undersigned acknowledges and understands that the dog training activities undertaken involve potential risk of personal injury and injury to personal property including dogs which may result from the undersigned's participation in dog training activities. Such injuries may be caused by other participants, the undersigned, facility conditions including, but not limited to, uneven or damaged terrain, the presence of moisture or mud, obstacles and obstructions upon or under the terrain and other natural or man-made conditions which may be hazardous to the undersigned or create hazards to the undersigned's activities. The undersigned further acknowledges that these dog training activities are potentially dangerous and assumes all risk of injury and damage which may result from any reason whatsoever thereby.

Binding Effect. The foregoing provisions shall be fully binding upon and shall be effective against the undersigned, its heirs, successors, legal representatives or assigns and shall apply to the actions of the undersigned personally, the undersigned's family, guests, employees or agents.

IN ADDITION: I hereby agree to abide by the rules of Love 2 Play Dog Training, **that no dog shall be physically reprimanded while engaged in any activity sponsored by or affiliated with Love 2 Play Dog Training**, or while on the premises leased or rented by Love 2 Play Dog Training (with the exception of dogs committing acts of aggression towards people or other dogs). **I further understand that any violation of this agreement could lead to the immediate termination of my involvement in the event or activity (including being asked to leave the premises) without refund of any monies paid for that event or activity.**

Refund & Service Policies

Please read this document carefully before registration. By confirming your registration, you are agreeing to these policies.

Our policies have been created under legal advisement and are similar to those common to elective educational programs and other professional services, in that once a deadline has passed, a program has begun and/or materials have been sent and/or received, there are no refunds or transfers permitted, other than those specified in this document.

Love 2 Play Dog Training welcomes all handler-dog teams, regardless of human proficiency or dog breed. We believe that everyone who is genuinely interested in learning how to train their canine friend should have that opportunity.

IMPORTANT: Love 2 Play Dog Training may refuse entry to any handler-dog team. It is the sole discretion of Love 2 Play trainers to remove a pet from class if a hazard or threat of any nature to any other animal or person is present. However, normally we will do our utmost to provide guidance and alternatives in such cases/situations.

CONFIRMATION: All classes and private sessions must be confirmed by payment. If your payment does not arrive by the agreed date and time and other arrangements have not been made, your reservation is immediately cancelled. Once your reservation is confirmed by payment, our refund policies apply. At that point you own only the dates, times, and services you have paid for.

TRANSFER BETWEEN CLASSES: Transfer between classes will only be permitted if space allows and the dog and handler are suited to that particular group. We have an online schedule that is accessible to all students on which you can sign in for a class or remove yourself if you can't make it (24 hours in advance, PLEASE).

NSF CHEQUES: You will be held legally responsible for all NSF cheques and the applicable charges. A service charge of \$50 will be charged on all NSF cheques. We reserve the right to certify any and all cheques at your bank before processing. All non-payments will be sent to collections after 60 days unless other arrangements have been made.

MISSED CLASSES: **If you know you will miss a class, please let us know. If at all possible, please remove yourself from your class in the online document 24 hours in advance. Most classes have waitlists.** There is no refund for missed classes. Flexible schedule OSR: Your pass is good for 12 weeks from the first class you take. It expires at that point and no refunds for unused classes will be given.

EMERGENCY CANCELLATIONS BY LOVE 2 PLAY: If cancellation is due to an uncontrollable event such as but not limited to; weather closures, hydro or furnace malfunction, trainer's vehicle breakdown or illness, we will do our best to contact you. An additional class will be added.

NON EMERGENCY CANCELLATIONS BY LOVE 2 PLAY: **Love 2 Play trainers attend upgrading seminars regularly. If we cancel a class we give as much advance warning as possible and additional weeks are ALWAYS added. The online SuperSaas document and schedule on the Love 2 Play website are always up to date.**

Animal Welfare Policy/Mission Statement

Love 2 Play Dog Training is committed to protecting the welfare of dogs and only using humane methods that are reward-based and evidence-based to train dogs.

Our employees and volunteers handle and treat animals with respect and in accordance with our Love 2 Play policies and standard operating procedures, as well as the federal, provincial and municipal regulations that govern our industry.

Any employee or volunteer who observes, or receives information that alleges an animal we are involved with is being mistreated, mishandled or treated or handled in a way that is contrary to our policies or procedures, must report that information to Jeanne Shaw immediately so that the situation can be corrected.

When any employee or other person reports an incident involving possible animal mistreatment Love 2 Play will take it seriously. We will document the concern and follow up on the animal's situation and take additional steps as necessary, including employee training if needed. Failure to follow this policy may be cause for dismissal.
